General Information

- Cost of Tuition Only: \$3,500 per term (\$14,000 for the year)
- Additional costs will include: Uniform, Stationery, School Trips.
- Minimum Length of Study: One Term
- Students must be 5-11 years of age during their time at Sunnyhills School.
- Students classified Year 1 to Year 6 must be living with a parent.
- Students must have a current Student Visa or Visitors Visa (if staying less than 3 months) before commencing study at Sunnyhills School.
- Change of Status: If the student's status changes (Permanent Residency granted) enrolment will be terminated and the student must re-enrol as a domestic student.
- Medical and travel insurance is compulsory and the responsibility of the parent.
